

## JNTO & ANA Online Travel Training (OTT) Competition

### Terms & Conditions

#### 1. WHO IS ELIGIBLE TO PARTICIPATE?

This Competition is open to UK & Ireland tour operators and travel agents and those who are residents of the UK aged 18 years or above. Proof of age and work status may be required at any stage of the Competition. Employees of 'All Nippon Airways co., Ltd', 'OTT Group Ltd.', Japan National Tourism Organization (JNTO), affiliates of any of the foregoing entities or their family members, or anyone else professionally associated with the competition, are not eligible to participate.
